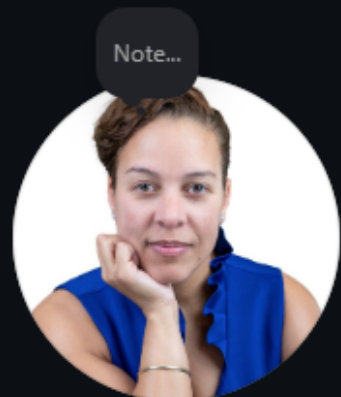

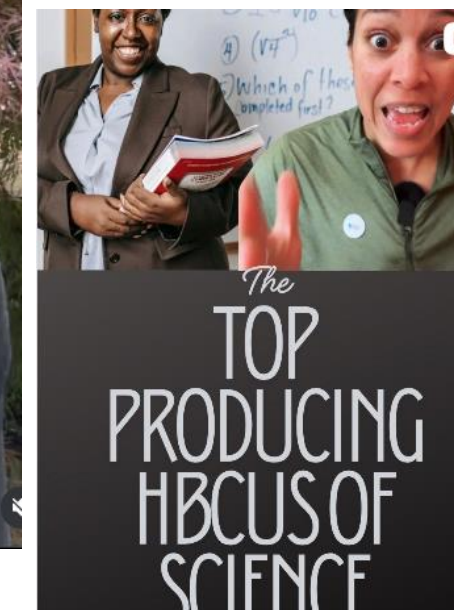

Proposal Development Workshop Summary

This workshop is designed for attendees without prior funding as an ECR PI and assumes they have already developed a one-pager for their ECR proposal idea. Facilitators will share their pearls of wisdom on turning a one-page proposal idea into a full-fledged competitive proposal. Facilitators will also discuss topics such as grant writing, partnership formation, and budget planning through hands-on activities, group discussions, and peer-to-peer networking opportunities. The workshop content will especially focus on the initial phases of turning an idea into an outline for a 15-page project description, while directing attendees to existing online resources for later proposal development stages after the Awardee meeting

- (1) Attendees will identify core components to a NSF ECR proposal
- (2) Attendees will determine alignment between core components and the standard ECR RFP format
- (3) Attendees will align their conceptual ideation with ECR RFP format

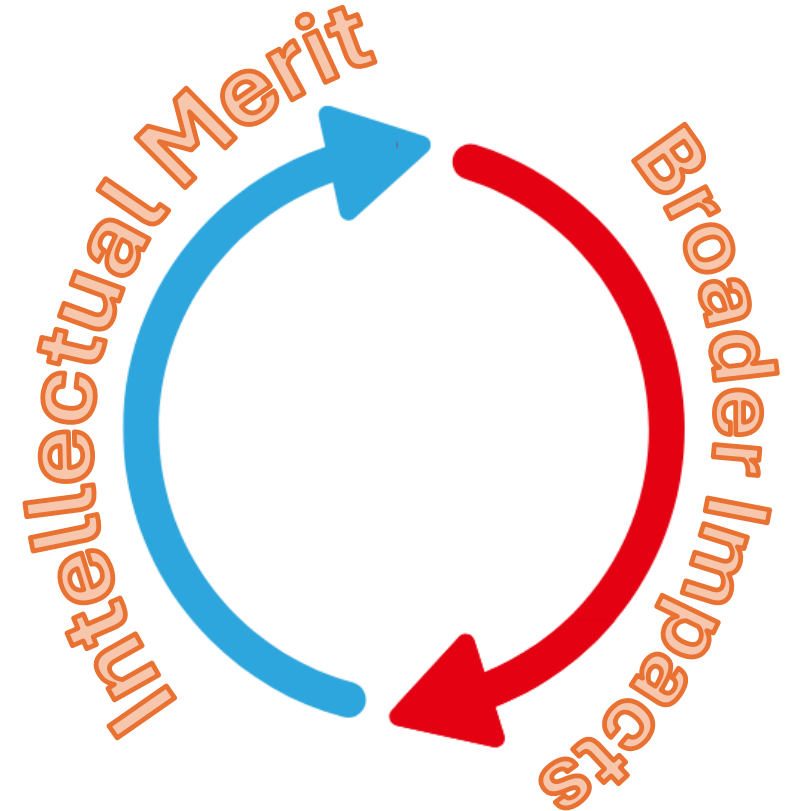
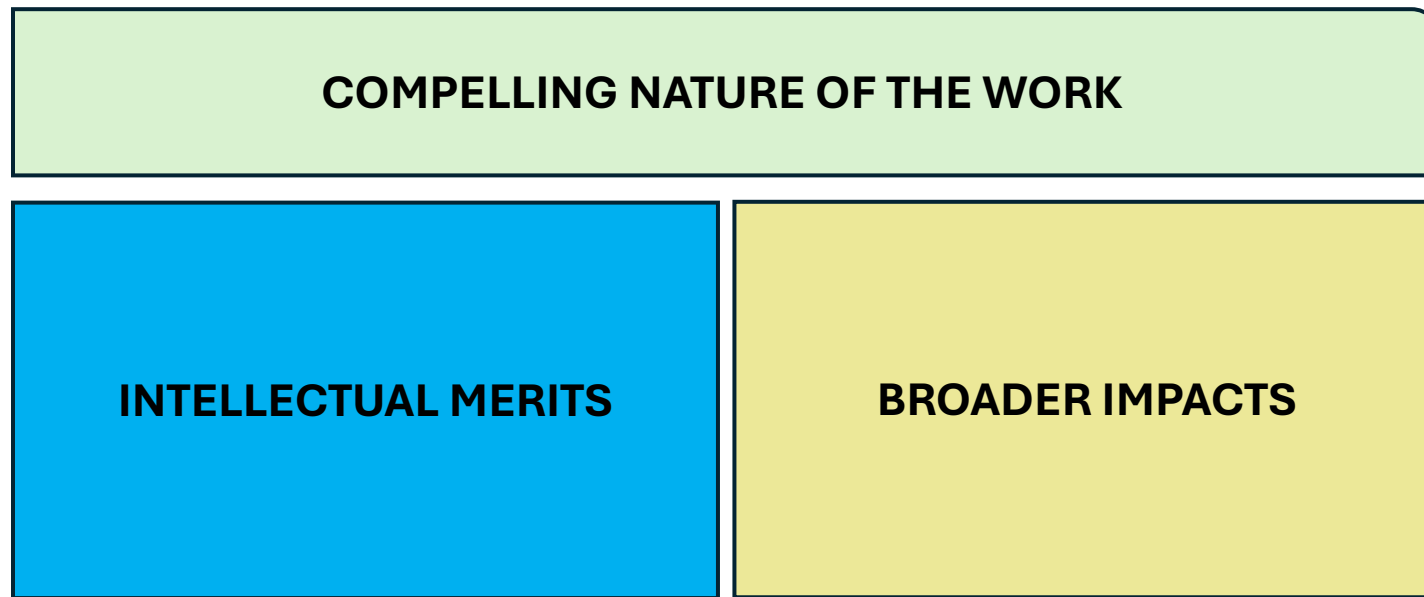

Science and Art to NSF Proposal Development

INTELLECTUAL MERITS

1. What is the potential for the proposed activity to advance knowledge and understanding within its own field or across different fields?
2. To what extent does the proposed activity suggest and explore creative, original, or potentially transformative concepts, approaches, activities, methods, etc.?
3. Is the plan for carrying out the proposed activities well-reasoned, well organized, and based on a sound rationale? Does the plan incorporate a mechanism to assess success?
4. How well qualified is the individual, team, or organization to conduct the project?
5. Is there sufficient access to resources? (Facilities and Equipment page, Data Management Plan technology referenced)

BROADER IMPACTS

The Broader Impacts criterion encompasses the potential to benefit society.

1. Increasing the economic competitiveness of the United States.
2. Advancing of the health and welfare of the American public.
3. Supporting the national defense of the United States.
4. Enhancing partnerships between academia and industry in the United States.
5. Developing an American STEM workforce that is globally competitive through improved pre-kindergarten through grade 12 STEM education and teacher development, and improved undergraduate STEM education and instruction.
6. Improving public scientific literacy and engagement with science and technology in the United States.
7. Expanding participation of women and individuals from underrepresented groups in STEM.

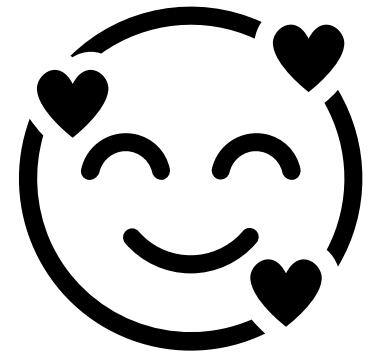
